The initial registration fee is HKD 2,000 (duration of two years), and renewal fee of registration is HKD 1,000 for every two years. After the first registration, if there is any change in the registration category, it is still considered as renewal of registration. The term is counted from January 1st to December 31st of each year, and if the registration is made at any time during this period, it will be regarded as one year until December 31st.
